### **General responses to conditions not met**

#### **Assessment**

Relative to PC and SC criteria, the visiting team report on the review of the M.Arch program firmly foregrounded the lack of robust per class, per criteria assessment documentation material as the significant reason for not meeting criteria requirements.

To address this fully and comprehensively the program has developed and implemented an extensive per criteria, per class assessment system for reviewing student performance relative to an evaluation rubric modeled on the NAAB rubric template.

The program will implement the review rubric into the SAIC Learning Management System (Canvas) in order to make the process of evaluation of student learning outcomes available to all faculty, easy to use and centrally updateable. The program will collect rubric based assessments yearly and review them for student learning outcomes. This will inform curriculum revision discussions with faculty and relevant institutional offices.

Outcomes of those rubric reviews leading to proposed curriculum modifications will be presented to the SAIC curriculum committee as course change recommendations, then implemented via yearly M.Arch course review and scheduling processes with full time faculty and departmental administration.

#### **Faculty support and resources**

Relative to support for faculty and staff, the visiting team report on the review of the M.Arch program expressed concern for appropriate resources for faculty and staff development, workload balancing and extra-curricular measures that contribute program improvement.

The administration is reviewing resources for producing a task and workload audit for M.Arch related work including: the Department Chair, Graduate Coordinator, Undergraduate Coordinator, NCARB Coordinator, NAAB Coordinator, DEI Coordinator, Assessment coordinator, administrative staff and full time faculty typical loads and adjunct faculty loads.
