Summer 2023 Financial Aid FAQ -- Study Trips

What does it cost?

Study trips are faculty-led classes and tuition are payable for the registered credits like any other class (i.e., undergraduate rate is \$1,785 per credit; graduate rate is \$1,860 per credit). Financial Aid and merit scholarships can applied be towards tuition for those who are eligible.

In addition, a **program fee** covering the costs of items such as accommodation, ground transport, some meals, and some admissions is payable. Each trip has a different program fee covering different items. Program fees do not usually cover airfare so be sure to budget for this additional expense. Eligible students can apply for alternative/private loans towards the program fee and the other expected costs of the trip not covered by the program fee. Some Graduate and dependent FAFSA applicants may also be eligible for and apply for additional Federal Direct PLUS loans. Ask the Student Financial Services office about this process and your eligibility. Program fees listed as "TBA" will be updated as costs are finalized.

How can I afford it?

Because special financial aid consideration is given for study trips, students not normally eligible for funds in some cases may receive assistance towards tuition. Some eligible students have received more financial aid than they expected. In addition, many students have been eligible for alternative/private loans towards the program fee and/or the extra costs (e.g., meals, etc.) not covered by the program fee. Some Graduate and dependent FAFSA applicants may also be eligible for and apply for additional Federal Direct PLUS loans. To find out more, submit an online financial aid application by completing preregistration in Self-Service.

How will I know how much financial aid/grants/loans I can receive — so I know if I can afford to sign up on the first day of registration?

When you complete preregistration, you are automatically applying for financial aid. A 2023-24 Free Application for Federal Student Aid (FAFSA) must be completed. If you do this by February 25, 2023 for summer 2023, the Student Financial Services office will calculate and send you a financial aid estimate in time for you to make your decisions before sign-up. Those not eligible for grants will be notified of any Federal Direct PLUS loan and alternative/private loan eligibility.

Can I still apply for study trip financial aid after the financial aid priority date?

Absolutely. The priority date is only the suggested deadline to have an answer before the first day of study trip registration. Applications submitted after that date will be processed as they are received.

What is the deposit for?

It is an advance on the cost of the class to reserve your space. The deposit will be credited to your account as the first payment. The rest of the trip will be charged when summer interim bills are issued.

How can I pay the deposit?

Important: Do not pay your deposit before you have successfully registered for the class because study trip deposits are non-refundable.

A nonrefundable \$525 deposit is required within 24 hours of your registration. Payment can be made by wire transfer, credit card (all major credit cards accepted – but a 2.75% processing fee is charged), or by electronic check (ACH – No additional processing fee is charged) via Transact. You can access Transact through the Financial Account > Make a Payment section of Self-Service. The deposit does not automatically appear as a charge in your student account. Here is how to make your deposit:

To Access Transact:

- 1. Log into SAIC Self-service at saic.edu/selfservice
- 2. Under Student Homepage choose "Financial Account" and select Transact

Once you are in Transact go to:

- 3. Your Account > Make a Payment or ARTICard Deposit
- 4. Select "Study Trip Deposit", choose the amount and term then select "Add to Shopping Cart"
- 5. Select "Checkout" and complete your payment by choosing your method of payment. The payment will be credited to your student account when all final steps are completed as instructed. Please note that wire transfers require that you instruct your banking institution to transfer funds after you complete the Transact steps.

Note: You may also pay by paper check or money order in US currency at the SAIC Bursar's office, Sharp Building, 37 South Wabash Avenue, suite 245 or the Student Financial Services office, Sullivan Center, 36 South Wabash Avenue, room 1200.

Can I rely on my financial aid package for the deposit?

No. The money will not be available by registration day so you must have another source of funding for the deposit.

Is the deposit refundable?

No. It will be used to pay for trip reservations, et al. However, if a trip is canceled by SAIC due to a lack of required participants, deposits will be refunded.

I do not understand the itemized program fee amounts for the study trip on my student account.

For Internal Revenue Service (IRS) reporting purposes and to maximize potential student/parent educational tax benefits, your study trip charges are broken down into categories consisting of tuition and program fees.

The program fees may be further divided into one or more of the following. The total of items #1 and #2 should equal the basic program fee:

- 1. Trip Program Fee-Travel Related: Covers items such as lodging, included meals, and travel expenses.
- 2. Trip Program Fee-Course Related: Covers expenses tied to course instruction such as faculty expenses, instructional costs, space rental, and required course activity fees.
- 3. Trip-Supplementary Travel: Will appear on your bill if you have opted for a group airfare, if a single room option is selected, and/or if items such as a travel visa were procured by SAIC on your behalf.

How can I receive financial aid and/or merit scholarship for the summer semester?

Students, if eligible, can apply for financial aid during the online preregistration process.

Am I eligible for Federal Direct Stafford loans during the summer term?

FAFSA students that are eligible to receive Federal Direct Stafford loans during the 2023-24 aid year may be eligible to receive them during summer as well. This eligibility may be reflected upon the estimate provided to you after pre-registration. For additional questions about your eligibility, please contact Student Financial Services.

Can my parent apply for a Federal Direct Parent PLUS loan for the summer term?

Parents of dependent students enrolled in 6 or more credit hours can apply for a Federal Direct Parent PLUS loan for the summer semester. For additional questions about your eligibility, please contact Student Financial Services.

Can graduate students apply for a summer Federal Direct Graduate PLUS loan?

Most Graduate students enrolled in 3 or more credit hours can apply for a Grad PLUS loan for summer. For additional questions about your eligibility, please contact Student Financial Services.

Once enrolled, when am I required to pay my outstanding balance?

Payment in full or payment arrangements must be made before your study trip begins.

Do I need to notify Student Financial Services if I decide to change my trip?

Yes, if you plan to change your trip please notify SFS at saic.sfs@saic.edu because your summer award may require an adjustment. Please include your full name, student ID number, the name of the new trip, and the amount of credit hours you will be enrolled in.

If I have a credit balance reflected on my account, when should I expect a refund?

Eligible students will receive their refund one week before they are expected to leave for their trip. Please remember to enroll for direct deposit refund on Transact (via Self-Service) in order for the funds to be directly deposited into your bank account.
